Questions and Notes from Pre-Proposal Meeting – November 30, 2017

- Who owns the Alley? Will it be a part of a future green-scape program? Answer: The alley has been vacated. How that space is used will be developed through the planning process.
- Are there overhead power lines? Answer: There are no overhead lines.
- Will there be artwork? Will there be a game area? Is there a theme for the Park? Answer: The park will go through a public engagement process to determine what amenities the park will have. There have been a lot of ideas to date, but there is a limited budget.
- Is the parking going to remain? Answer: The partnership agreement anticipates that 24 parking spaces will need to be incorporated into the site, generally along the 12th Street side of the site.

The highest-scoring proposers *MAY be* asked for an interview. However, in the event one company is the clear best choice for this project, we will not burden you with interviews.
