## RESOLUTION NO. 1165

## AS AMENDED

BY THE COUNCIL: FRAZER, HEITINGER, KOCH, ONWEILER, PERRY and RICE

A RESOLUTION DEFINING A CERTAIN AREA WITHIN BOISE CITY AS A GENERAL NEIGHEORHOOD RENEWAL AREA, DIRECTING THE CRBAN RENEWAL AGENCY OF BOISE CITY TO DEVELOP AND UNDERTAKE THE PREPARATION OF A GENERAL NEIGHBORHOOD RENEWAL PLAN FOR THE AREA HEREIN DESCRIPED

BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY CF BOISE CITY, IDAHO; as follows:

MIEREAS, on the 23rd day of August, 1965, the Mayor and Council of Boise City duly adopted Resolution No. 1154 whereby the Urban Renewal Agency of Boise City was appointed and created and Boise City was designated, under the provisions of Chapter 246, 1965 Idaho Session Laws, as an area whereby it was deemed necessary to formulate for said city an Urban Renewal Agency to fulfill and to enforce the provisions of said statutes of the State of Idaho, and

WHEREAS, it is, by the Mayor and Council of Boise City, deemed necessary and feasible to designate an area for the exercise of the business and powers granted by the statutes of the State of Idaho, above mentioned, and to carry out and effectuate the purpose and provisions of the said statute of the State of Idaho consistent with and in relation with an Urban Renewal Plan;

MC %, THEREFORE, it is further resolved as follows:

Section 1. That it is desirable and in the public interest that the Urban Renewal Agency of Boise City develop a General Neighborhood Renewal Plan, and for that purpose to develop a plan as a guide for the provision of public improvements within the area hereinafter described, to formulate regulatory measures affecting property within such areas, and to submit to the Council and Mayor of Boise City a comprehensive plan relating to the development,

redevelopment, rehabilitation and conservation of property within the following described area, to wit:

Commencing at the northeast corner of the intersection of Third and Washin ton Streets going thence west along the north line of Washington Street to the northwest corner of the intersection of Ninth and Washington Streets; thence south along the west line of Ninth Street to the northwest corner of the intersection of Minth and State Streets; thence west along the north line of State Street to the northwest ecrmer of the intersection of Twelfth and State Streets; thence south along the west line of Twelfth Street to the southwest corner of the intersection of Twelfth and Front Streets; thence east along the south line of Front Street and Front Street extended to the southeast corner of the intersection of Front Street extended and Third Street extended; thence north along the east line of Third Circet extended and Third Street to the northeast corner of the intersection of Third and Washington Streets, the place of beginning.
