BY THE COUNCIL: BUERSMEYER, EWING, JENSEN, KOPKE, McADAMS AND ONWEILER

AN ORDINANCE REVOKING, TERMINATING AND CANCELLING APPOINTMENTS OF MEMBERS TO THE BOARD OF COMMISSIONERS OF THE BOISE REDEVELOPMENT AGENCY: APPOINTING AND DESIGNATING THE COUNCIL AS THE BOARD OF COMMISSIONERS OF THE BOISE REDEVELOPMENT AGENCY. AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, pursuant to Resolution No. 1154 adopted and approved respectively by the Council and Mayor on August 22, 1965, the public body politic and corporate known and designated as the Boise Redevelopment Agency (also known as the Urban Renewal Agency of Boise City) was created to perform the powers, functions and duties prescribed by the provisions of Chapter 20, Title 50, Idaho Code,

WHEREAS, pursuant to Resolution No. 1165 adopted and approved respectively by the Council and Mayor on April 25, 1966, a general neighborhood renewal area was established by which to conduct and perform urban renewal activities and to prepare an urban renewal plan(s) or project(s) for the general neighborhood renewal area consistent with the capacity and resources of the Boise Redevelopment Agency;

WHEREAS, pursuant to provisions of said Resolution No. 1154 and Section 50-2006, Idaho Code, the Mayor has heretofore with the advise and consent of the Council appointed members to the Board of Commissioners of the Boise

Redevelopment Agency; and

WHEREAS, pursuant to the authority contained within and as provided by S.L. 1976, Chapter 256 (amending Section 50-2006, Idaho Code), the Council at its regular meeting of August 2, 1976 and effective as of August 21 1976, terminated and cancelled the appointment of the present office holders to the Board of Commissioners of the Boise Redevelopment Agency and thereby appointed and designated itself as, and each and every member of the Council a member of, the Board of Commissioners of the Boise Redevelopment Agency to be vested with all the rights, powers, duties, privileges and immunities vested in a Board of Commissions of an Urban Renwal Agency as provided by the provisions of Chapter 20, Title 50, Idaho Code.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF BOISE CITY, IDAHO:

Section 1. Effective as of August 21, 1976, the term of office held by each member of the Board of Commissioners of the Boise Redevelopment Agency shall expire, and the appointment of each individual member to said Board of Commissioners shall be, and the same hereby is, revoked, terminated and cancelled as of August 21, 1976.

Section 2. As of <u>August</u> 23, 1976, the Council of Boise City shall be, and it hereby is, designated as, and each and every member of the Council shall be, and they hereby are, appointed as a member of, the Board of Commissioners of the Boise Redevelopment Agency to be vested with all the rights, powers, duties, privileges and immunities vested in a Board of Commissioners of an Urban Renewal Agency as provided by the provisions of Chapter 20, Title 50, Idaho Code.

Section 3. This Ordinance shall be in full force and effect from and after its passage, approval and publication hereof.
