

ORDINANCE NO. 4778

BY THE COUNCIL:

COLES, MCADAMS, SELANDER, TATE,
TRAIL AND TWILEGAR.

AN ORDINANCE REPEALING BOISE CITY ORDINANCE NO. 3854, DATED AUGUST 2, 1976, WHICH APPOINTED AND DESIGNATED THE BOISE CITY COUNCIL AS THE BOARD OF COMMISSIONERS OF THE BOISE REDEVELOPMENT AGENCY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, pursuant to Ordinance No. 3854 dated August 2, 1976, the Council of Boise City was designated as, and each and every member of the Council was appointed as a member of, the Board of Commissioners of the Boise Redevelopment Agency and vested with all the rights, powers, duties, privileges and immunities vested in a Board of Commissioners of an Urban Renewal Agency as provided in Chapter 20, Title 50, Idaho Code; and

WHEREAS, the Boise City Council at its regular meeting of April 16, 1984, determined that it no longer wishes to serve as the Board of Commissioners of the Boise Redevelopment Agency but desires the Mayor with the advice and consent of Council, to appoint a new Board pursuant to authority contained within Idaho Code §50-2006.

WHEREAS, by virtue of Chapter 20, Title 50, Idaho Code, the Council must approve any modification of the urban renewal plans for downtown Boise, cooperate with the Agency for development of the urban renewal project area through the City's planning and zoning laws, may enter into such arrangements as may be necessary to carry out the urban renewal plan, and must agree to appropriate to the Agency, those certain federal funds by virtue of contractual agreements with the United States Department of Housing and Urban Development.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF BOISE CITY, IDAHO:

Section 1. That Boise City Ordinance No. 3854 dated August 2, 1976, be, and the same hereby is repealed.

Section 2. That effective April 23, 1984, all development contracts, typically entitled Disposition and Development Agreements must be approved by the Council, before said agreements shall become effective.

Section 3. That this Ordinance shall be in full force and effect from and after its passage, approval and publication.

WHEREAS, by virtue of Chapter 20,
Title 50, Idaho Code, the Council must
approve any modification of the urban
renewal plans for downtown Boise, co-
operate with the Agency for develop-
ment in the urban renewal project
area through the City's planning and
zoning laws, may enter into such ar-
rangements as may be necessary to
carry out the urban renewal plan, and
must agree to appropriate to the
Agency those certain federal funds by
virtue of contractual agreements with
the United States Department of Hous-
ing and Urban Development.

BE IT ORDAINED BY THE
MAYOR AND COUNCIL OF THE
CITY OF BOISE CITY, IDAHO:

Section 1. That Boise City Ordinance
No. 3854 dated August 2, 1976, be, and
the same hereby is repealed.

Section 2. That effective April 23,
1984, all development contracts, typi-
cally entitled Disposition and Develop-
ment Agreements must be approved
by the Council, before said agree-
ments shall become effective.

Section 3. That this Ordinance shall
be in full force and effect from and
after its passage, approval and publi-
cation.
