1.2 NOTICE TO BIDDERS

- A. This Addendum is issued pursuant to the Conditions of the Contract. This addendum serves to clarify, revise, and supersede information in the Project Manual and Drawings. Portions of the Addendum affecting the Contract Documents will be incorporated in the Contract by enumeration of the Addendum in the Owner/Contractor Agreement.
- B. The Bidder shall acknowledge receipt of this Addendum in the appropriate space on the Bid Form.
- C. The date for receipt of bids is unchanged by this Addendum, at same time and location.

1.5 QUESTIONS

- A. The following questions were asked during the prebid meeting and bid period from August 30 – September 17, 2026. The following answers are provided by Owner to assist the Bidders.

1. **Q:** How do you want to handle warranty for SD card failures?

ANSWER: The five-year camera warranty does not extend the specified SD card media warranty beyond the manufacturer's standard warranty. In the event of SD card failure, continuous cloud recording remains available while cloud connectivity is maintained. Failed SD card media shall be replaced as required by the Contractor during the standard manufacturer warranty period to restore full edge-recording functionality. No additional SD card warranty requirement is added by this Addendum.

2. **Q:** Is there video surveillance and access control integration at 1010 W Jefferson (10J)?

ANSWER: No. Active integration between the video surveillance system and the access control system at 1010 W. Jefferson is not required as part of this Contract. Provide the video surveillance system as a standalone system at initial deployment. The VMS shall provide future integration capability as required by Section 28 20 00.

3. **Q:** Please provide the specifications for the network switch.

ANSWER: Existing Owner network switches shall be utilized to the extent of the available capacity identified in this Addendum. Contractor shall determine the port count and PoE requirements of its proposed video surveillance system. Where the proposed system exceeds the identified available capacity, Contractor shall furnish and install additional managed PoE network switching equipment meeting the requirements of the proposed cameras and VMS. No specific manufacturer or model is required for additional switches. Final switch configuration, VLANs, uplinks, and installation shall be coordinated with the Owner and Parking Operator.

4. **Q:** Who pays for Ground Penetrating Radar (GPR) scans of concrete?

ANSWER: Refer to Concrete Penetration and Scanning notes section on plan sheet T-001. Owner will contract and pay for the GPR/scanning services. Contractor shall provide coring, drilling, and/or cutting services.

5. **Q:** Please provide information on the use of a staging area at the 11th and Front Garage.

ANSWER: Contractor will be allowed up to 100 Square Feet of storage space within the ParkBOI enclosure at this garage.

6. **Q:** Can conduit be installed on the exterior façade of the building?

ANSWER: Conduit is not permitted to be installed on the exterior of a building on any façade abutting a public street or alley. Conduit may be installed on the exterior of a building only where the exterior façade is not visible to the general public on a public street (e.g. where the façade abuts an adjacent building next to the property line and there is no publicly occupiable space between the buildings).

7. **Q:** After reviewing the contract requirements with our internal contracts and insurance specialist, we would like to request consideration for a waiver of the \$5 million cyber liability insurance requirement outlined in the project manual. Would CCDC consider a \$3 million cyber liability policy?

ANSWER: See revised Section 00 73 16 Insurance and Bonding (attached)

- 1.02 Bidder accepts all of the terms and conditions of the Advertisement or Invitation to Bid and Instructions to Bidders, including without limitation those dealing with the disposition of Bid security. The Bid will remain subject to acceptance for sixty (60) days after the Bid opening, or for such longer period of time that Bidder may agree to in writing upon request of CCDC.
- 1.03 Within thirty (30) days from receiving a written notice of acceptance of this Bid, Bidder shall execute the Contract and shall deliver evidence of required insurance coverages and bonds in the amounts required by the Contract.
- 1.04 In submitting this Bid, Bidder represents, as set forth in the Contract and Project Manual, that:

- b. Bidder has visited the Site and become familiar with and is satisfied as to the general, local, and Site conditions that may affect cost, progress, and performance of the Work.
- c. Bidder is familiar with and is satisfied as to all federal, state, and local Laws and Regulations that may affect cost, progress, and performance of the Work.
- d. Bidder has carefully studied: 1.) all reports of explorations and tests of subsurface conditions at or contiguous to the Site and all drawings of physical conditions in or relating to existing surface or subsurface structures at or contiguous to the Site, if any, which have been identified in the Project Manual; and 2.) all reports and drawings of a Hazardous Environmental Condition, if any, which has been identified in the Project Manual.
- e.  - j. The Project Manual is generally sufficient to indicate and convey understanding of all terms and conditions for the performance of the Work for which this Bid is submitted.

- 1.05 Bidder represents that this Bid is genuine and not made in the interest of or on behalf of any undisclosed individual or entity and is not submitted in conformity with any agreement or rules of any group, association, organization, or corporation; Bidder has not directly or indirectly induced or solicited any other Bidder to submit a false or sham Bid; Bidder has not solicited or induced any individual or entity to refrain from bidding; and Bidder has not sought by collusion to obtain for itself any advantage over any other Bidder or over CCDC.

- 1.07 Bidder agrees that the Work will be substantially completed and fully completed ready for final payment in accordance with General Conditions on or before the dates or within the number of calendar days indicated in the Contract Documents. Bidder accepts the provisions of the Contract as to liquidated damages in the event of failure to complete the Work within the times specified.

and experience for construction of Project and in any and all other respects to meet with and consult with any Bidder or any other person, entity, or group.

- c. Waive any formalities or defects as to form, procedure, or content with respect to its Bid Invitation and any responses by any Bidder thereto.
- d. Accept or reject any sealed Bid received in response to the Bid Invitation, including any sealed Bid submitted by the undersigned; or select any one submission over another.
- e. Accept or reject all or any part of any materials, plans, drawings, implementation programs, schedules, phrasings and proposals or statements, including, but not limited to, the nature and type of Bid.

INSURANCE. Prior to commencing services under this Agreement, Contractor shall procure and maintain at its sole cost and expense, and thereafter maintain for the term of this Agreement, at least the minimum insurance coverages set forth below. All insurance policies shall be written by insurers licensed in the state where the Services or Work are being performed and having an AM Best Rating no less than A-:VII at policy inception. Contractor shall provide CCDC with certificates of insurance and necessary endorsements before commencing its performance as herein provided, and thereafter, within five (5) days of policy renewal or replacement. Contractor shall notify CCDC a minimum of thirty (30) days prior to cancellation of said policy or policies or ten (10) days if due to non-payment of premium.

- (a) Worker's compensation as required by applicable law or regulation. If worker's compensation insurance is not required under the circumstances, Contractor shall provide proof to CCDC that such coverage is not required; and,
- (b) Employer's liability insurance in the minimum amount of \$100,000 per employee for bodily injury, \$100,000 per employee for bodily injury by disease and \$500,000 aggregate for bodily injury by disease; and,
- (c) Commercial general liability insurance (CGL) with minimum limits of \$1,000,000 per occurrence, and a minimum general aggregate policy limit of \$2,000,000. The commercial general liability insurance policy shall name CCDC and its officers, agents, and employees as an Additional Insured and coverage shall apply on a primary and non-contributory basis. The CGL policy shall include coverage for bodily injury, property damage, personal and advertising injury, independent contractors and products-completed operations; and,
- (d) Business automobile liability insurance with minimum limits of \$1,000,000 combined single limit per accident for bodily injury and property damage. Coverage shall include any owned, non-owned, leased or hired vehicle and CCDC and its officers, agents, and employees shall be listed as an Additional Insured and coverage shall apply on a primary and non-contributory basis; and,
- (f) Installation Floater. In effect at all times during the performance of the Work in an amount sufficient to cover the replacement value of all cameras, communications equipment, network devices, control equipment, specialty security equipment, and other materials to be incorporated into the Work until Final Acceptance by Owner, and,
- (g) Cyber Liability, with limits of not less than Three Million Dollars (\$3,000,000) per claim and Three Million Dollars (\$3,000,000) aggregate. Coverage shall include, at a minimum: (a) network security liability arising from unauthorized access to, unauthorized use of, denial of access to, introduction of malicious code into, or failure of security affecting computer systems, networks, applications, or electronic data; (b) privacy liability arising from the loss, theft, disclosure, unauthorized access, unauthorized use, corruption, destruction, or alteration of confidential information, personal information, protected information, or other sensitive data maintained, processed, transmitted, or controlled by Contractor; (c) security breach response costs, including forensic investigation, legal services, breach notification, public relations services, call center services,

identity theft protection, and credit monitoring expenses; (d) regulatory defense costs, fines, penalties, and assessments, where insurable by law; (e) data recovery, data restoration, and system restoration costs; (g) business interruption, contingent business interruption, and extra expense losses arising from cyber events or system failures; (f) cyber extortion, ransomware, and cybercrime events; (g) social engineering fraud, computer fraud, and funds transfer fraud; (h) system failure, network outage, denial-of-service attacks, and operational technology failures.

Any applicable deductible or self-insured retention shall be the sole responsibility of Contractor.

If the policy is written on a claims-made basis, Contractor shall maintain such coverage continuously throughout the term of this Agreement and for a period of not less than three (3) years following completion or termination of the Services. Retroactive dates, if any, shall be no later than the effective date of this Agreement.

Contractor may include all subcontractors as insureds under the Contractor's policies in lieu of separate policies by each subcontractor.

Failure of Contractor to provide insurance as herein required or failure of Owner to require evidence of insurance or to notify Contractor of any breach by Contractor of the requirements of this Section shall not be deemed to be a waiver of any of the terms of the Contract Documents, nor shall they be deemed to be a waiver of the obligation of Contractor to defend, indemnify, and hold harmless the indemnified parties as required herein. The obligation to procure and maintain any insurance required is a separate responsibility of Contractor and independent of the duty to furnish a copy or certificate of such insurance policies.

Payment and Performance Bonds

Payment and Performance Bonds are required of the Contractor. Such bonds shall be issued by a surety admitted in the state of Idaho, payable to Owner, and must be acceptable to the Owner to be valid. The Owner's acceptance shall not be withheld without a reasonable cause. The penal sum of the bonds shall each be one hundred percent (100%) of the original Contract Price. Any increase in the Contract Price that exceeds ten percent (10%) in the aggregate shall require a rider to the Bonds increasing penal sums accordingly. Up to such ten percent (10%) amount, the penal sum of the bond shall remain equal to one hundred percent (100%) of the Contract Price. The Contractor shall endeavor to keep its surety advised of changes potentially impacting the Contract Price and Contract Time, though the Contractor shall require that its surety waives any requirement to be notified of any alteration or extension of time within the scope of the initial Agreement. The performance bond shall include coverage in favor of Owner for correction of Defective Work by the Contractor for two years following Substantial Completion of the Work.
